Facts about Lakeville

Originally settled by the Wampanoag Indians

Lakeville has a rich history as it served as home to many Wampanoag Indians dating back to the 1600's. One of the first land transactions is a recorded deed from 1667.

Incorporated in 1853

Lakeville was incorporated in 1853, after separating from Middleboro. Other suggestions for the name of the town were Nelson, Bristol, and Laketon.

The Town Hall – Past & Present

In 1853 a building committee was nominated to establish an official meeting place for the Town. The building, which sits at the corner of Precinct and Bedford Streets, served as the Town Hall for almost 100 years. The current town office building is housed in a pumping station built by the City of Taunton in 1894. The Town of Lakeville purchased the building in 1952.

American Bald Eagles

In 1993 a nest that held American Bald Eagle chicks was discovered on Assawompset Pond. Over twenty years later, the eagles still reside on the Pond. With a bit of luck and good timing they can sometimes be seen soaring over Lakeville.

Population

In 1879 the population of Lakeville was 1,061.

As of the 2020 Federal Census there were 11,523 residents.

Dog Licenses

All dogs 6 months and older need to be licensed in accordance with Mass. General Laws. The licensing is required by April 30th each year. Rabies vaccinations have to be up-to-date in order to obtain a license. Single licenses (not kennels) may be purchased through the mail sending the license fee along with a copy of the rabies certificate and a self-addressed stamped envelope to the Town Clerk's Office. The current fee for a neutered male or a spayed female is \$10.00 and \$16.00 for a dog that is not altered. Kennels vary in price according to the size of the kennel. *Licenses paid after April 30th are subject to a \$50.00 late fee; licenses paid after September 30th are subject to a \$100.00 late fee.* **Residents should notify the Town Clerk's office if they no longer have a dog that was previously licensed.**

**BURNING PERMITS**

The burning of brush, cane, trees, and driftwood (from other than commercial, institutional or residential land clearing operations) is allowed with a permit between January 15th and April 30th; 10:00am-4:00pm. Burning of grass, hay, leaves, stumps, and construction materials is prohibited. Permits can be obtained from the Lakeville Fire Department at 346 Bedford Street. The fee for the permit is \$10.00. Prior to burning, all residents must contact the Fire Department to obtain permission.

Outdoor Points of Interest

Betty's Neck (Assawompset Pond Complex) – Off Long Point Road. Located along the shores of Assawompset Pond Betty's Neck provides 350 acres for walking, hiking and picnicking. Mountain biking on established trails is also allowed, along with more passive recreation like nature study, photography and artistic work. Dogs are allowed but must be leashed. Shoreline fishing is allowed in some areas and hunting permits are issued yearly by lottery. Contact the APC Manager at 508-946-8823 for additional information.

Clear Pond Park – Clear Pond Road. Open from late June – August. Clear Pond Park is a 57-acre recreational swimming facility suitable for children of all ages. Facilities include a small playground, diving raft, picnic sites and barbeque grills, a snack bar and restrooms. Daily and seasonal passes are available.

Tamarack Park – Bedford Street. The Tamarack Park is a 44-acre site at the head of Assawompset Neck. The park is a mix of marsh and upland and provides a picnic area as well as a canoe launch into Long Pond.

Ted Williams Camp - Precinct or Bedford Streets. Ted Williams Camp offers an active recreational site in the center of Lakeville. It is the home of the local soccer, little league and youth football leagues. There are baseball diamonds, soccer fields, tennis courts, sand volleyball courts, basketball courts, and horseshoe pits. The newly renovated Loon Pond Lodge is available for rent for a variety of social occasions.

HELPFUL INFORMATION – AT A GLANCE

TOWN HALL HOURS: M-TH 8:00AM-4:30PM, F- 8:00AM-NOON | SELECTMEN'S OFFICE: M-TH 9:00AM-5:00PM, F- 8:00AM-NOON

- THERE IS A TOWN CLERK DROP BOX FOR TOWN CLERK BUSINESS & A SEPARATE PAYMENT BOX FOR TAX PAYMENTS (CHECKS ONLY) LOCATED OUTSIDE OF TOWN HALL -

REAL ESTATE/PERSONAL PROPERTY TAX:

- Quarterly bills due Aug. 1st, Nov. 1st, Feb 1st & May 1st. Fiscal Tax Year (July 1st-June 30th.)
- Tax bills will be mailed twice a year, normally by July 1st & January 1st.
- Each bill will contain Two Payment Coupons, one for each quarter.
- Request for previous year's tax information – Contact the Treasurer/Tax Collector's Office at (508)946-8801.

EXCISE TAX:

- The first mailing occurs in late Jan- early Feb. Additional mailing occur throughout the year.
- When transferring/cancelling a plate, contact the Assessor's office at (508) 946-8809. You must fill out and submit an abatement form with the cancelled plate receipt in order to receive your abatement.

TOWN CENSUS:

- Mailed in late December. Complete, sign/date form & return to the Town Clerk's Office.
- It is very important to respond to the Census, as sending 2nd notices are an added expense to the residents of Lakeville.
- The Census establishes legal residence for voting privileges & town benefits. It is also the vehicle by which annual street lists are printed for distribution to police, fire and medical personnel. It is the census figures that are used to determine grants or to receive state and federal reimbursements and aide. School enrollments are also based on town census.
- The census form **does not register you to vote.**

TOWN MEETING:

- Please monitor the town's website (www.lakevillema.org), town's Facebook page, LakeCAM, local newspaper and sign at the four corners in the center of Lakeville.
- Annual Town Meeting – 2nd Monday in May (General By-Laws; Ch.2 §.2)
- Special Town Meeting – continue to monitor through proper channels listed above for date/time.
- A copy of the warrant will be posted at: The Town Office Building, Baldies Pizzeria, Fat Cousin's Pizza, the Clark Shores Assoc. bulletin board, Apponequet Regional High School, the Senior Center & Assawompsett School.

VOTER REGISTRATION:

- Voter registration forms are available at the Town Clerk's Office, Library, Online and the RMV.
- You can register to vote on the Secretary of State's website at: <https://www.sec.state.ma.us/ovr/>
- If you are a registered voter and move out of Lakeville, it is very important to notify the Town Clerk's Office at (508) 946-8800.

ELECTIONS:

- All elections for Precinct 1, 2 & 3 are located at Loon Pond Lodge at Ted Williams Camp; 28 Precinct Street.
- Annual Town Election – 1st Monday in April from 12:00pm-8:00pm. (General By-Laws; Ch.2 §.1)
- A copy of the warrant will be posted at: The Town Office Building, Baldies Pizzeria, Fat Cousin's Pizza, the Clark Shores Assoc. bulletin board, Apponequet Regional High School, the Senior Center & Assawompsett School.

DOG LICENSES:

- Available January 2nd each year. Proof of rabies certificate is required (spay/neuter if applicable.)
- Fees: Male/Female - \$16, Neutered/Spayed - \$10
- Late fees: After April 30th – Fifty Dollars (\$50.00), After October 1st – One Hundred Dollars (\$100.00)
- If you no longer have your dog, please contact the Town Clerk's Office.
