

## Lakeville Historical Commission Meeting Minutes of August 17, 2023

Co-Chairman Joan Morton called the monthly meeting of the Lakeville Historical Commission to order at 7:43 pm at the Historic Town House. In attendance were Joan Morton, Geri Taylor, and Nancy LaFave. Guests: LakeCam. Co-Chairman Morton asked if anyone was recording the meeting. The answer was yes, LakeCam.

**Secretary's Report:** Minutes of the July 20, 2023 meeting were “**accepted with a correction**” with a motion made by LaFave and seconded by Taylor. The motion passed.

**Treasurer's Report:** The Historical Commission's balance was \$500. The Scholarship balance is \$3,000 non-expendable and the expendable balance is \$822.99. The 150<sup>th</sup> Anniversary Account has a balance of \$3,444. 97. The Gift Account balance is \$300. The report was “**accepted as presented**” with a motion by LaFave and seconded by Taylor.
