On November 6, 2023, the Lakeville Arts Council held a meeting at 7 PM at the Lakeville Police Station meeting room. The meeting was called to order at 7:03 by Chairman Joanne Corrieri-Upham. Members present were Robin Fielding, Jacqueline Kennedy, Michelle Darling, Marcia Young, and Chairman Joanne Corrieri-Upham. LakeCam was recording the meeting for broadcast.

Review and Vote on 31 FY 2024 Grants

Chairman J. Corrieri-Upham asked if a member wanted to make a motion that the committee does not have to discuss all seventeen (17) Lakeville grant applications that they individually read.

Upon a motion made by Member M. Darling and seconded by Member M. Young, it was:

VOTED: To not require the committee to discuss all seventeen (17) Lakeville grant applications.

Unanimous approval

Chairman J. Corrieri-Upham identified each of the seventeen (17) Lakeville grant applicants, their project titles, and the amount of money that they were requesting.

Upon a motion made by Member M. Darling and seconded by Member J. Kennedy, it was:

VOTED: To approve \$7,225 for all seventeen (17) Lakeville grant applications. Unanimous approval

Chairman J. Corrieri-Upham advised that the committee had a total of \$9,409 to give to grant applicants. After approving the \$7,225 for the Lakeville grant applications, the committee has \$2,184 left to give out to other grant applicants. Chairman J. Corrieri-Upham stated that the committee likes to award grants for events that are happening in Lakeville, but they do support other local events. She noted that three (3) additional grant application events will take place in Middleboro and one (1) will take place in Lakeville and Freetown.

Chairman J. Corrieri-Upham stated that there are also ten (10) applications for events outside of the area, and according to the applications, they will be held in Dudley, Bridgewater, Plainville, Brockton, Plymouth, Rochester, New Bedford, Northbridge, "unknown" because this is a virtual performance with no venue, and Ipswich.

Chairman J. Corrieri-Upham asked the committee to vote on the three (3) grants that will take place in Middleboro and the one (1) grant that will take place in Lakeville and Freetown.

Upon a motion made by Member M. Young and seconded by Member R. Field, it was:

VOTED: To approve the application for Theatre One Productions, Inc, Slice of Life New Works Festival, in the amount of \$300.

Unanimous approval

Upon a motion made by Member J. Kennedy and seconded by Member R. Field, it was:

VOTED: To approve the application for Susan Hotchkiss, Jazz Concert UU Society Middleboro, in the amount of \$500.

Unanimous approval

Upon a motion made by Member M. Young and seconded by Member M. Darling, it was:

VOTED: To give Soule Homestead and Andrea Lovett \$692 each. Unanimous approval

Soule Homestead Education Ctr, Music & Events at Soule Homestead, requested \$1,500 and was awarded \$692.

Lovett, Andrea, Once Upon a Generation/Lakeville/Freetown, requested \$1,200 and was awarded \$692.

The remaining grant money had been awarded, bringing the balance to \$0.00. Upon a motion made by Member M. Darling and seconded by Member R. Field, it was:

VOTED: To deny the remaining ten (10) applications from outside of the area. Unanimous approval
